You are invited to apply to the **Aerospace Academy**, a special summer academic experience, held **July 12 – July 22, 2021**. The event will run from 9:00 a.m. through 11:30 a.m. (Pacific Time) every Monday through Thursday. The purpose of the academy is to expose students to the possibilities of becoming STEM (Science, Technology, Engineering, and Mathematics) professionals in the future by directly immersing them in the aerospace industry and culture that The Aerospace Corporation provides. Participants will complete activities and solve educational prompts that relate to real-world technical problems. During the Academy, participants will be provided a mentor as well as opportunities to meet with STEM professionals and observe the groups working to achieve mission success. The requirements for students to apply to the Academy are as follows:

1. Be a first generation college student (neither parent attended a four-year college)
2. Must be a citizen of the United States, living in the United States
3. Currently attend a Title I school and have a minimum cumulative GPA of 2.75
4. Must have access to an electronic device (computer) and stable internet
5. Must have their own email address
6. Be enrolled in 12th grade for the 2021-2022 school year or have graduated 12th grade in 2021

Each individual must complete the four-part application: general information; personal statement; parent consent forms (if under 18 years of age); and recommendation by a teacher, counselor, or administrator at the school of attendance. The deadline for the applications is **Friday, May 28, 2021**.

Upon submission of the completed application, a small group of volunteers will read and select the most qualified applicants for the Aerospace Academy. Once the selection process has been completed, the participants will be notified by email and must accept or decline their participation. Prior to the event, **ALL** participants must complete and return all forms (including; parental consent and release, and release for recordings). Failure to provide signed waivers and releases will result in disqualification from participation in the Academy.

Participants must use their own email to communicate with event organizers. Student participants may not share the event link or meeting details with others not accepted to the program and who have not complied with the security requirements.

Upon completion of the Aerospace Academy participants should expect to have exposure to technical concepts associated with several Information Systems fields key to The Aerospace Corporation (e.g., Cybersecurity, Data Science), a better understanding of technical concepts, and gained valuable learning experiences that can be of benefit when completing college applications.
